<u>ISSUE</u>

Adopt Resolution No. CC 2022-019, a Resolution of the City Council of the City of Palmdale Authorizing Remote Teleconference Meetings of the City Council and All City Subordinate Bodies for the period of February 21, 2022 through March 23, 2022.

RECOMMENDATION

Staff recommends that the City Council:

 Adopt Resolution No. CC 2022-019, a Resolution of the City Council of the City of Palmdale Authorizing Remote Teleconference Meetings of the City Council and All City Subordinate Bodies for the period of February 21, 2022 through March 23, 2022.

BACKGROUND

On September 16, 2021, the Governor signed AB 361 which temporarily amends the Ralph M. Brown Act (*California Government Code* §§54950, et. al.) to provide more flexibility regarding participation in public meetings from a remote location.

AB 361 went into effect October 1, 2021 and expires on January 1, 2024.

DISCUSSION

AB 361 requires several procedural safeguards to encourage maximum public participation during a remote meeting, key ones of which are summarized as follows:

- 1. The public must have the ability to address the legislative body directly and must be given information on how to address the legislative body;
- 2. The public must be provided with either a call-in or internet-based service option;

- The legislative body must stop the meeting if the call-in or internet-based option fails;
- 4. The legislative body cannot require that public comments be submitted in advance (although this option can be provided);
- 5. Public speakers cannot be required to pre-register for public comment (except as required by an independent call-in or internet platform);
- 6. Members of the public must be given a reasonable time to register to provide public comment; and
- 7. Agencies that provide a timed public comment period shall not close the public comment period until that time period has expired.

The proposed resolution would continue to permit meetings pursuant to AB 361 for a maximum period of 30 days (February 21, 2022 through March 23, 2022).

Beyond this procedural requirement, there are no additional changes to the currently established procedures regarding providing a teleconferencing option for public meetings of the City Council and all of its subordinate bodies.

Accordingly, Staff recommends approval of Resolution No. CC 2022-019.

WHEREAS, the City of Palmdale is committed to preserving and fostering public access and participation in meetings of the City Council and all its subordinate bodies, as required by the Ralph M. Brown Act (*California Government Code* §§54950, et. al.), so that any member of the public may attend and participate as the bodies conduct the public's business; and

WHEREAS, the Brown Act makes special provisions for remote teleconferencing participation in meetings where the Governor has exercised his authority pursuant to *California Government Code* § 8625, and an in-person meeting may present imminent health risks to elected, appointed, or sitting members during public meetings; and

WHEREAS, the City Council of the City of Palmdale finds that the recitals found to be true and correct in Resolution No. CC 2021-102 (passed on October 20, 2021), incorporated herein by reference, continue to exist making remote participation in meetings important to ensure the public is given full opportunity to participate; and

WHEREAS, the City Council of the City of Palmdale finds that the City Council and all of its subordinate bodies shall conduct their meetings with remote participation in the manner authorized by *California Government Code* §54953(e), and such legislative bodies shall comply with the requirements to provide the public with access to the meetings as prescribed by *California Government Code* § 54953(e)(2).

NOW THEREFORE, BE IT RESOLVED, THE CITY COUNCIL OF THE CITY OF PALMDALE DOES HEREBY FIND, DETERMINE, RESOLVE AND ORDER AS FOLLOWS:

SECTION 1. The Recitals set forth above are true and correct and are incorporated herein by reference.

SECTION 2. The City Council and its subordinate bodies shall conduct their meetings with remote participation in a manner authorized by *California Government Code* §54953(e), and such legislative bodies shall comply with the requirements to

provide the public with access to the meetings as prescribed by *California Government Code* §54953(e)(2).

SECTION 3. This Resolutions shall take effect immediately upon its adoption and shall be effective until the earlier of December 20, 2021, or such time as the City Council adopts a subsequent resolution in accordance with *California Government Code* §54953(e)(3) to extend the time during which meetings may continue to be held remotely by teleconference in compliance with that section.

SECTION 4. The City Clerk shall certify to the adoption of this resolution.

<u>ISSUE</u>

Adopt Resolution No. CC 2022-021, a Resolution of the City Council of the City of Palmdale to approve the street name change of Avenue R-12, between 65th to 70th Street East, to be named Hawks Way.

RECOMMENDATION

It is recommended that the City Council adopt Resolution No. CC 2022-021, authorizing the City to change the street name of Avenue R-12, between 65th to 70th Street East, to be named Hawks Way.

BACKGROUND

Staff has been petitioned by the Antelope Valley Union High School District to change the street name for Avenue R-12, between 65th to 70th Street East, to be named Hawks Way. This segment of Avenue R-12 borders the southern portion of Pete Knight High School. Currently this roadway ends at the westerly boundary line of the High School and serves as one of the main student drop-off points. In the future, with the current construction of subdivision Tract 61611 and 61891, roadway improvements along Avenue R-12 will be extended to connect with 65th Street East.

To change the name of said segment of Avenue R-12 will involve changing 1 standard street name sign that is at the intersection of Avenue R-12 and 70th Street East. This action will not require any changes to property addresses, as there are no business or residence that addressed along this street, as Pete Knight High School is addressed from 70th Street East.


SECTION 1. That portion of the City street now known as "Avenue R-12" between 65th Street East to 70th Street East shall henceforth be designated as "Hawks Way".

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALMDALE, TO SUPPORT THE RECALL OF LOS ANGELES COUNTY DISTRICT ATTORNEY GEORGE GASCON

- **WHEREAS**, the City of Palmdale, values and places the highest priority on public safety and protecting its community; and
- **WHEREAS**, the City of Palmdale, strives to maintain effective public safety and protection for life, property and the environment, as stated in Goal I of the Strategic Plan.
- **WHEREAS**, Los Angeles County District Attorney George Gascon issued a series of Special Directives in December 2020, including Special Directives 20-06, 20-07, and 20-08; and
- **WHEREAS**, Special Directive 20-06 eliminates cash bail for any misdemeanor, non-serious felony, or non-violent felony offense; and
- WHEREAS, Special Directive 20-07 lists numerous misdemeanor charges that will be declined or dismissed before arraignment and without conditions unless "exceptions" or "factors for consideration" exist. These misdemeanor charges include trespassing, disturbing the peace, criminal threats, drinking in public, drug and paraphernalia possession, being under the influence of a controlled substance, public intoxication, resisting arrest, driving without a valid license or with a suspended license, minor in possession of alcohol, loitering, and loitering to commit prostitution; and
- **WHEREAS**, Special Directive 20-08 eliminates several sentencing enhancements, including the Three Strikes Law, gang enhancements, and violations of bail; and
- **WHEREAS**, some of the Special Directives issued by Los Angeles County District Attorney George Gascon contradict state law, which were enacted through the legislative or ballot initiative process to prevent and prosecute crime and protect the general public; and
- **WHEREAS**, the Special Directives listed in this Resolution undermine the legislative and ballot initiative process and risk safety of the general public; and
- **WHEREAS**, the Special Directives undermine the deterrent effects of various criminal laws and penalties that were meant to protect the public, including the residents of the City of Palmdale; and

WHEREAS, the City of Palmdale adopted Resolution CC 2021-074, which was a vote of no confidence in Los Angeles County District Attorney George Gascon; and

WHEREAS, it is of the utmost importance for the City of Palmdale, that policies that aim to restructure or amend prosecutorial directives are consistent with state law and issued with reasonable intent and priority to enhance public safety and protect the general public and victims' rights.

RECOMMENDATION

BACKGROUND

Bradley, Gmelich & Wellerstein (previously Bradley Gmelich) has competently provided legal services to the City of Palmdale for more than a decade. The City Attorney's Office would like to continue to use their services for various legal matters. Agreement A-7819 would retain Bradley, Gmelich & Wellerstein for up to three (3) years.

DISCUSSION

Under the proposed agreement with Bradley, Gmelich & Wellerstein, the firm would continue to provide legal services pertaining to personal injury and property damage defense. This work would also include cross claims, counter claims, summary judgments and all manner of motions, discovery proceedings, trials, and post-trial and appellate work. In addition, the firm would provide general advisory services related to such claims and lawsuits and the prevention of future claims and lawsuits. The City will be charged rates between \$135 and \$275 per hour. All billings are on the 1/10th hour basis. The firm also charges for items such as applicable court fees, messenger, courier and air freight expenses, parking expenses, local and out-of-town travel expenses, mileage, computerized and other research costs, long distance telephone expenses, conference call expenses, facsimile and other communication expenses, postage, and printing costs.

AGREEMENT FOR LEGAL SERVICES BETWEEN THE CITY OF PALMDALE AND BRADLEY, GMELICH & WELLERSTEIN LLP

AGREEMENT NO. A-7819

This Legal Services Agreement ("Agreement") is made and entered into by and between the City of Palmdale ("City") and Bradley, Gmelich & Wellerstein LLP ("Firm"), collectively identified as "the parties."

RECITALS:

- A. This Agreement is made pursuant to California Business and Professions Code Section 6148, and is intended to fulfill the requirements of that section.
- B. The City desires to retain the Firm to provide specialized legal services related to the areas of civil litigation and personal injury defense, general advisory services related to municipal law and business practices, as well as legal services related to employment law litigation, advice and counsel.
- C. The attorneys of the Firm are duly licensed under the laws of the State of California and are fully qualified to provide the services contemplated by this Agreement.

THE PARTIES AGREE AS FOLLOWS:

1. Scope of Services.

- a. The Firm will provide those legal services as may be authorized and assigned by the Palmdale City Attorney, including, without limitation, legal services related to personal injury and property damage defense, employment law defense, cross claims, counter claims, summary judgments and all manner of motions, discovery proceedings, trials, and post-trial and appellate work, as well as general advisory services related to such claims and lawsuits and the prevention of future claims and lawsuits. The firm will provide those legal services reasonably required to accomplish City's stated goals.
- b. The legal services the Firm will provide to City will be billed at the rates set forth in Exhibit "A", attached.

2. Designation of Responsible Attorneys.

Barry Bradley, Esq. is designated as the attorney responsible for providing the legal services under this Agreement to City and for supervising

any other attorneys within the Firm assisting him in the performance of those services. The Firm's offices are located at 700 North Brand Boulevard, 10th Floor, Glendale, CA 91203.

3. Confidentiality.

All reports, information, data, or other documents prepared or assembled by the Firm under this Agreement are confidential and the Firm shall not make the same available to any individual or organization without the prior written approval of the Palmdale City Attorney.

4. <u>Maximum Contract Amount, Billing Procedures, and Monthly Statements.</u>

- a. The Firm shall submit to the Palmdale City Attorney, within thirty (30) days after the end of each calendar month, an itemized statement of the professional services provided and the time expended providing those services. This statement will be in the form customarily submitted by the Firm to clients that are billed on an hourly basis. The parties acknowledge that payment of all monthly statements is expected to be made within thirty (30) days of the billing date.
- b. The Firm will bill the City for items such as, but not limited to, long distance telephone calls, filing fees (if applicable), document duplication, computerized legal research, word-processing, and similar out-of-pocket expenditures. These items will be separately designated on the Firm's monthly statements as "disbursements," and will be billed in addition to the fees for professional services.
- c. If the Firm's services are billed by the hour, time will be charged by the Firm in increments of 1/10 of an hour (i.e., six-minute units). Among the services which are routinely billed are telephone conversations and travel time. In addition to the fees charged for services, the Firm also bills for costs incurred, which include, but are not limited to, filing fees (if applicable), messenger and air courier expensed, parking expenses, local and out-of-town travel expenses, facsimile and other communication expenses, postage, and printing costs. In addition, the Firm charges for certain internal costs if incurred on City's behalf, such as photocopying, secretarial overtime, and word processing.

The rate structure in general, or the rates of particular attorneys, may be increased from time to time, after a minimum 30-day written notice to and written consent of the Palmdale City Attorney. To the extent feasible, these adjustments will be made so as to coincide with the beginning of City's fiscal

year, which begins on July 1st. If possible, requests to increase fees should be forwarded to the Palmdale City Attorney in February of any given year.

- d. The Firm's fees for legal services are based primarily on hourly rates; other factors considered by the Firm in determining a fair fee are set forth in Rule 4-200 of the Rules of Professional Conduct of the California State Bar Association. If persons who are "Of Counsel" to the Firm work on City matters, the Firm and its Of Counsel may from time to time share the fees paid by City; however, if such is the case, City's fees will not be increased in any way, and the fees which City is requested to pay will be the same as would have been payable had there been no such sharing of fees.
- e. All fees, charges, costs and reimbursable items for the entire term of this Agreement shall not exceed a maximum of \$250,000.00.

5. Resolution of Fee Disputes.

City is entitled to require that any fee dispute be resolved by binding arbitration in Los Angeles in accordance with the arbitration rules of the Los Angeles County Bar Association for legal fee disputes. If City chooses not to use the Los Angeles County Bar Association's arbitration procedures, City agrees that any disputes regarding the professional services rendered or fees charged by the Firm will be submitted to binding arbitration in Los Angeles to be conducted by the American Arbitration Association (or an alternative provider if the Parties so agree) in accordance with its commercial arbitration rules.

6. **Term of the Agreement.**

This Agreement will take effect on February 16, 2022 and will remain in full force and effect for a period of three (3) years or until terminated in accordance with the provisions of Section 7.

7. Termination of the Agreement.

City has the right to terminate the Firm's representation at any time, without cause, subject to an obligation to give notice in writing to the Firm at least thirty (30) days prior to termination. The Firm has the same right, subject to an obligation to give City written notice at least ninety (90) days prior to termination so that City will be able to arrange alternative representation. In either circumstance, City agrees to secure new counsel as quickly as possible and to cooperate fully in the substitution of the new counsel as counsel of record in any pending litigation matters. The Firm agrees to cooperate fully in any such

transition, including the transfer of files. Upon termination, all finished or unfinished materials shall become the property of City. Notwithstanding the termination of the Firm's representation, City will remain obligated to pay to the Firm all fees and costs incurred prior to such termination.

8. <u>Modifications to the Agreement.</u>

Unless otherwise provided for in this Agreement, modifications relating to the nature, extent, or duration of the Firm's professional services to be rendered will require the written approval of the Palmdale City Attorney. Any such written approval will be deemed to be a supplement to this Agreement and will specify any changes in the Scope of Services and the agreed-upon billing rate to be charged by the Firm and paid by the City.

9. **Independent Contractor.**

No employment relationship is created by this Agreement with the Firm or any employees of the Firm. For all purposes, the Firm and its employees are independent contractors to City and shall not incur, nor have the authority to incur any debt, obligation, or liability for or against City.

10. **Assignment and Delegation.**

This Agreement contemplates the performance of professional services by the Firm. Neither this Agreement, nor any portion of it, may be assigned or delegated by the Firm without the prior written consent of the Palmdale City Attorney. Delegation to attorneys outside the Firm will be limited to those situations in which the Firm is disqualified by virtue of a conflict of interest, or where the Firm does not possess the expertise to perform services in a particular practice area. The Firm will supervise delegated work, except where precluded from doing so by virtue of a conflict of interest, and where otherwise agreed to by the parties.

11. Conflict of Interest.

The Firm affirms that it presently has no interest and shall not have any interest, direct or indirect, which would conflict in any manner with the performance of the services contemplated by this Agreement. No person having such interest shall be employed by or associated with the Firm.

12. **Insurance.**

- a. The Firm shall obtain and maintain in full force and effect a professional liability insurance policy that provides coverage in an amount not less than \$1,000,000 per occurrence. This insurance policy shall provide coverage to the City for any damages or losses suffered by City as a result of any error, omission, or neglect by the Firm that arises out of the professional services rendered under this Agreement. Such insurance may be subject to a self-insured retention or deductible to be borne entirely by the Firm.
- b. The Firm will obtain and maintain workers' compensation insurance in accordance with Section 3700 of the California Labor Code.
- c. The Firm will obtain and maintain in full force and effect comprehensive general liability insurance in an amount not less than \$1,000,000 per occurrence with a \$2,000,000 aggregate.
- d. All insurance coverage specified above will provide for a minimum of thirty (30) days notice of cancellation by the insurance carrier, and will be maintained in full force and effect throughout the term of this Agreement.

13. **Legal Files.**

- a. During the period that the Firm is actively working upon a matter, the files pertaining thereto will be maintained in its offices. Files may be maintained in physical files or electronically. After the Firm has concluded working upon a matter, any physical files will be destroyed within a reasonable time in a confidentially safe manner. Electronic files will be maintained for a period of five years. City is free to request any of its original physical files or documents at any time, and further request that the original files not be destroyed for a specified period of time not to exceed four years from the date of file closure. All original agreements, modification or deeds, easements or similar original documents should be forwarded to the Palmdale City Clerk either as created or at the conclusion of a case. City may request copies of its client matter files at any time, including, without limitation, upon termination of the Firm's engagement. City agrees that upon delivery of any client matter files that it will pay the Firm for its costs incurred in photocopying such files.
- b. If the firm is called upon to give testimony or produce documents in any legal or administrative proceeding which concerns City in any way, whether before or after the representation and rendition of legal services to

City under this agreement terminates, City agrees to pay the Firm, at it's then prevailing hourly rates, for it's time in investigating, preparing for and in giving testimony and/or in producing documents and for all expense incurred in connection with doing so.

14. **Entire Agreement**

This Agreement will constitute the full and complete agreement and understanding of the parties and supersedes all prior agreements and all other written or oral statements of either party relating to its subject matter.

- 2. Adopt one of the other proposed district boundary maps **not** recommended by the Advisory Redistricting Commission and direct staff to bring back Ordinance No. 1579, An Ordinance of the City Council of the City of Palmdale Adopting a Map Describing Voting District Boundaries and Amending Chapter 4.10 of Title 4 of the Palmdale Municipal Code at the March 2, 2022 City Council meeting for introduction and formal adoption.

BACKGROUND

Every ten years, California cities with by-district election systems must use new census data to review and, if needed redraw district lines to reflect how local populations have changed. This process, called redistricting, ensures all districts have nearly equal population. The redistricting process for the City of Palmdale must be completed by April 17, 2022.

The City of Palmdale adopted its current district boundaries in 2016 based on 2010 census data, as required by law. The district boundaries must now be reconsidered using

the 2020 census data and in compliance with the Fair and Inclusive Redistricting for Municipalities and Political Subdivisions ("FAIR MAPS") Act, which was adopted by the California legislature as AB 849 and took effect January 1, 2020. AB 1276 is a subsequent clean-up of AB 849 and took effect on January 1, 2021.

FAIR MAPS ACT and REDISTRICTING REQUIREMENTS:

Under the Act, the City shall draw and adopt district boundaries using the following criteria, in the listed order of priority (See, California Elections Code §21621, et. al.):

- 1) Comply with the federal requirements of equal population and the Voting Rights Act:
- 2) Geographically contiguous;
- 3) Undivided neighborhoods and "communities of interest" (socio-economic geographic areas that should be kept together);
- 4) Easily identifiable boundaries;
- 5) Geographic compactness (do not bypass one group of people to get to a more distant group of people); and,
- 6) Shall not favor or discriminate against a political party.

Once the prioritized criteria are met, other traditional districting principles can be considered, such as:

- 1) Minimize the number of voters delayed from voting in 2022 to 2024;
- 2) Respect voters' choices / continuity in office; and
- 3) Future population growth.

By law, the City must hold at least four public hearings that enable community members to provide input on the drawing of district boundary maps:

- At least one public hearing must be held before the City Council or Advisory Redistricting Commission draws a draft map or maps of the proposed district boundaries;
- At least two of the public hearings shall be held after the City Council or Advisory Redistricting Commission has drawn a draft map or maps of the proposed district boundaries; and
- At least one public hearing or public workshop shall be held on a Saturday, on a Sunday, or after 6 p.m. on a weekday Monday through Friday.

To increase the accessibility of these hearings, the City of Palmdale must additionally take the following steps:

 At least one public hearing or public workshop shall be held on a Saturday, on a Sunday, or after 6 p.m. on a weekday Monday through Friday;

- Public hearings shall be accessible to persons with disabilities; and
- If a public hearing is consolidated with a regular or special meeting of the council that includes other substantive agenda items, the public hearing must begin at a fixed time regardless of its order on the agenda.

ESTABLISHMENT OF THE PALMDALE ADVISORY REDISTRICTING COMMISSION:

See, Resolution No. CC 2021-031, Section 13.

ADVISORY REDISTRICTING COMMISSION MEETING (FEBRUARY 9, 2022):

On January 20, 2022, the Advisory Redistricting Commission held a Special Meeting to discuss, reconsider, and make a second recommendation of the proposed district boundary map or maps based upon the statement provided by the City Council on February 2, 2022. After reconsidering the maps and in accordance with Resolution No. CC 2021-031, the Advisory Redistricting Commission recommended three district boundary maps:

CITY COUNCIL CITY OF PALMDALE, CALIFORNIA RESOLUTION NO. CC 2021-031

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PALMDALE ESTABLISHING A REDISTRICTING COMMISSION PURSUANT TO ELECTIONS CODE SECTION 23000

WHEREAS, members of the City Council of the City of Palmdale ("City") adopted Ordinance No. 1471, transitioning from at-large to by-district city councilmember elections under Elections Code § 10010; and

WHEREAS, the City Council are currently elected in "district-based" election, in which each city councilmember is elected only by the voters in the district in which the candidate resides; and

WHEREAS, Elections Code 21601 and 23000 authorizes the City Council to appoint a redistricting Commission; and

WHEREAS, the City Council desires to receive input on district boundaries from a geographically diverse sector of the community; and

WHEREAS, the Fair Maps Act (AB 849) became effective January 1, 2020 and created standardized redistricting criteria aimed to keep communities together and to prohibit partisan gerrymandering. The Act also expanded community outreach and public hearing requirements and timelines, which coincide with the State redistricting schedule (ATTACHMENT 1); and

WHEREAS, the SB 1018 became effective on January 1, 2019 expanding the methods for re-drawing district maps. Under this legislation, in addition to appointing an advisory, or an independent commission, the City Council may instead elect to appoint a hybrid commission or contract with Los Angeles County's Citizen Redistricting Commission ("CRC"), as outlined in the Authorities and Criteria for Redistricting Commissions (ATTACHMENT 2) and provides for detailed information for each commission):

- a. the City Council may adopt districts itself, and
- b. the City Council may appoint an <u>advisory commission</u> to recommend district boundaries for City Council adoption; and
- c. the City Council may establish an <u>independent redistricting commission</u> to adopt or new boundaries to the City; and
- d. the City Council may establish a <u>hybrid redistricting commission</u> to either adopt or recommend new boundaries to the City.

- NOW, THEREFORE BE IT RESOLVED, that the City of Palmdale, acting by and through its City Council, having considered and been fully advised in the matter and good cause appearing therefore does hereby resolve as follows:
- <u>SECTION 1. Establishment.</u> There shall be established the Palmdale Redistricting Commission, hereinafter "Commission" which shall be an Advisory Commission pursuant to Elections Code §23001. The Commission shall be established by June 1, 2021 and shall exist until the City Council adopts an ordinance establishing City Council district boundaries for the November 2022 election.
- <u>SECTION 2. Membership</u>. The Commission shall consist of 11 Commission members. Commission members shall consist of a diverse group of residents.
- <u>SECTION 4. Selection Process</u>. The Commission member selection process is designed to produce a qualified and impartial Commission. Commission members shall be selected through an open application process. Any person who meets the minimum Commission member qualifications in Section 5 may apply to serve on the Commission. Commissioners shall be appointed as follows
 - A. The City Clerk shall initiate and widely publicize the Commission application process. To promote a large and diverse applicant pool, the City Clerk shall seek assistance from a broad range of community-based organizations to encourage qualified persons to apply. The application period shall be open through the earliest statutory date required.
 - B. At the end of the application period, the City Clerk shall review and verify the information contained in each application, including applicants' eligibility to serve on the Commission under Section 5. The City Clerk shall remove from the applicant pool any applicant who does not meet the minimum Commission member qualifications.
 - C. The applicants may be considered taking into account the following factors:
 - (1) The Commission should not be comprised entirely of members who are registered to vote with the same political party preference.
 - (2) Commission members should reasonably reflect the City of Palmdale's diverse geography and reside in diverse areas throughout the city.
 - (3) Race/ethnicity may be considered without using formulas, quotas or ratios.
 - (4) Gender, age, economic class, sexual orientation and party registration may be considered in selecting Commission members.
 - (5) Commission members shall be impartial, know the jurisdiction's neighborhoods and communities, appreciate the jurisdiction's diversity and work well with others.

- D. Commission members shall be appointed as follows: each Councilmember shall appoint two Commission members, and the remaining three Commission members shall be appointed by the Mayor, with all proposed appointees subject to confirmation by a majority of the Council.
- <u>SECTION 5. Eligibility Requirements for Members of the Commission</u>. The application process shall be open to all eligible residents. The following qualifications and restrictions are imposed on members of the Commission:
- A. A person, or the family member of a person (i.e., spouse, registered domestic partner, parent, sibling, child or in-law), who has done any of the following in the preceding eight years, shall not be appointed to serve on a Commission:
 - (1) Been elected or appointed to, or been a candidate for, an elective office of Palmdale.
 - (2) Served as an officer of, employee of, or paid consultant to, a campaign Commission or a candidate for elective office of Palmdale.
 - (3) Served as an officer of, employee of, or paid consultant to, a political party or as an elected or appointed member of a political party central Commission.
 - (4) Served as a staff member of, consultant to, or contracted with, a currently serving elected officer of Palmdale.
 - (5) Been registered to lobby in Palmdale.
 - (6) Contributed five hundred dollars (\$500) or more in a year to any candidate for an elective office of Palmdale.
- B. A member of the Commission shall not do any of the following:
 - (1) While serving on the Commission, endorse, work for, volunteer for, or make a campaign contribution to, a candidate for an elective office of Palmdale.
 - (2) Be a candidate for an elective office of Palmdale for 5 years commencing with the date of his or her appointment to the Commission.
 - (3) For four years commencing with the date of his or her appointment to the Commission:
 - a. Accept an appointment to a Palmdale Board, Commission or Commission.

- b. Accept employment as a staff member of, or consultant to, an elected official or candidate for elective office of Palmdale.
- c. Receive a noncompetitively bid contract with Palmdale.
- d. Register as a lobbyist in Palmdale.
- C. Must be a resident of Palmdale and resided in Palmdale for at least the past three years.
- D. Must be a registered voter. Those residents not eligible to vote due to age or citizenship but have a Permanent Resident Card (Green Card) are exempt from this requirement.

<u>SECTION 6. During and Post-Service Restrictions</u>. Commission members shall comply with the following during and post-service restrictions as contained in California Elections Code Section 23003(d):

- A. While serving on the Commission, members may not work for, volunteer for, or make a campaign contribution to, a candidate for an elective office of Palmdale.
- B. Commission members may not run for an elective office of Palmdale for 5 years commencing with the date of my appointment to the Commission.
- C. For four years commencing with the date of his or her appointment to the Commission, members shall not:
 - (1) Accept an appointment to a Palmdale Board, Commission or Commission.
 - (2) Accept employment as a staff member of, or consultant to, an elected official or candidate for elective office of Palmdale.
 - (3) Receive a noncompetitively bid contract with Palmdale.
 - (4) Register as a lobbyist in Palmdale.

<u>SECTION 7. Redistricting Criteria</u>. The Commission shall take into account the following legally required criteria in recommending district boundaries:

- A. Each city council district shall contain a nearly equal population;
- B. A redistricting plan shall be drawn in a manner that complies with the Federal Voting Rights Act, the California Voting Rights Act and the Equal Protection Clause of the U.S. Constitution; and
- C. City Council districts shall not be drawn with race as the predominate factor.

D. The Commission may also adopt its own criteria consistent with this Section 7 and may consider additional criteria, including the criteria set forth in Elections Code 21601, such as including topographical and geographical boundaries (major roads, freeways, creeks, railroad lines or other barriers) and communities of interest (school district boundaries, neighborhood boundaries, retail/commercial districts, voting precincts etc.).

<u>SECTION 8. Public Transparency</u>. The Commission shall implement an open process for public input and Commission deliberation as follows:

- A. The Commission members shall file Form 700 Statement of Economic Interest
- B. forms.
- C. The Commission shall comply with the California Public Records Act, commencing with Section 6250 of the California Government Code, and the Ralph M. Brown Act, commencing with Section 54950 of the California Government Code.
- D. The Commission shall publish on the internet and make available to the public a draft version of a proposed final map before final recommendation to the City Council.
- E. All records of the Commission relating to redistricting, and all data considered by the Commission in drawing a draft map or proposed final map, are public records.
- F. The City shall establish and make available to the public on the internet a calendar of all public hearings.
- G. The City shall establish and maintain for ten years a webpage for the Commission where important redistricting materials may be published, including hearing agendas, hearing minutes, links to hearing audio or video recordings where applicable, a Commission member roster, and draft maps created by the Commission.
- H. Commission members shall disclose all contact regarding the Commission's subject matter jurisdiction that occurs outside of a publicly noticed meeting. Commission members shall disclose these contacts no later than the Commission's next regular or special meeting.
- I. Any person who is compensated for communicating with the Commission or any Commission member, other than a reimbursement of reasonable travel expenses, shall identify the party compensating them in such communication.

<u>SECTION 9. Public Engagement</u>. The Commission and the City should actively encourage residents to participate in the redistricting process.

- A. The Commission shall make every reasonable effort to afford maximum public access to its proceedings.
- B. The City shall solicit broad public participation in the redistricting process, including from residents of communities that traditionally participate less frequently in the local political process. At minimum, the City shall:
 - (1) Develop and present a proposed outreach campaign to the City Council at a public meeting;
 - (2) Conduct an outreach campaign to educate the public on the redistricting process and how to be involved; and
 - (3) Request the assistance of neighborhood associations, community groups, civic organizations, and civil rights organizations with engaging residents in the redistricting public review process.

<u>SECTION 10.</u> Commission Meetings. The hearing location shall be accessible to persons with disabilities and, to the extent practicable, shall have free parking nearby and be accessible by public transit. Public hearings shall be scheduled at various times and days of the week to accommodate a variety of work schedules and to reach as large an audience as possible. The Commission shall establish and implement a process for accepting written public comment, including the submission of draft maps and draft partial maps for the Commission's consideration.

SECTION 11. Administration. A quorum shall consist of a majority of the seated Commission members (i.e., if eleven members are seated, a quorum shall be six members). The Commission may only recommend a plan for district boundaries and election sequencing with a majority vote of the seated Commission members (i.e., if eleven members are seated, six votes would be needed). All other Commission actions, other than maps and sequencing, require only a majority vote of those present, provided that a quorum is present. The City Council or the Commission may remove a Commission member for substantial neglect of duty, gross misconduct in office, or inability to discharge the duties of office. Before being removed, a Commission member must be provided with the reasons for their proposed removal, at least a week's notice of the public hearing where his or her proposed removal will be voted on, and an opportunity to respond to or rebut those reasons in writing and at the hearing.

<u>SECTION 12. Staff Support</u>. The City Manager, City Clerk, and City Attorney shall designate staff to support the Commission, as needed.

<u>SECTION 13. Schedule.</u> The Commission shall forward its final recommendation regarding a proposed district map to the City Clerk by no later than January 21, 2022. Upon receipt of the recommendation, the City Clerk shall immediately cause the recommended map(s) to be published for a seven-day public review period. Thereafter, the City Council shall conduct a public hearing on the Commission

proposed map(s). At this hearing the City Council may elect to: (1) direct staff to introduce an ordinance approving one of the Commission recommended maps/sequencing or (2) reject the map(s)/sequencing and return it to the Commission for reconsideration with a statement of the reasons for such disapproval and request the Commission to modify the map(s)/sequencing. If the City Council rejects the Commission's recommendation, the Commission shall have up to seven days (but in no event later than January 28, 2022) to submit a revised map(s)/sequencing to the City Council for further consideration. Upon receipt of the revised map(s) the City Clerk shall immediately cause the maps to be published for a seven-day public review period.

SECTION 14. Statement of Council Intent: It is the intention of the City council to adopt one of the redistricting maps recommended by the Commission.



Introduction

The City of Palmdale has launched an aggressive outreach effort to reach across the entire Palmdale community to engage and educate the public about the redistricting process. This Outreach Summary Report is intended to provide a high-level overview of the outreach philosophy, process and results to date.

Key highlights from these communication efforts include:

- Repeated email or phone contact with nearly 120 people and organizations to proactively outreach to key influencers, community leaders and community-based organizations with redistricting related information, including hearing agendas and meeting information.
- Rollout of the Redistricting website, <u>DrawPalmdale.org</u>, where extensive resources are
 available for the public to learn about the redistricting process, access all the materials
 and meeting information, and to draw maps based upon their understanding of
 communities of interest and submit them for consideration in the future.
- Flyers in English and Spanish to promote upcoming community meetings
- 117 English and Spanish social media posts spread across Facebook, Instagram and Twitter from August through February.
 - Instagram 34 posts
 - Facebook 38 posts
 - Twitter 45 posts
- Billboard that reads "Send Your Map"
- Radio commercials on Spanish radio talk show, including 1410 am and 1470 am
- Magazine advertisements in Palmdale Magazine in Palmdale Connections
 - o Palmdale Magazine Summer 2021, Fall 2021 and Winter/Spring 2022
 - o Palmdale Connections Jan/Feb 2022, Nov/Dec. 2021, Sept/Oct. 2021
- Press releases in English and Spanish distributed to the City's media contacts. The
 redistricting process was featured 14 times by external news sources, including The
 Antelope Valley Times and Antelope Valley Press.

A Unique Timeline Challenge

The redistricting process that was triggered by the 2020 Census is unique as a result of the delay in release of the Census data. In normal years, the Census data would become available in April of the year after the Census (April 2021), but due primarily to the impact of the Coronavirus Pandemic, the data release was delayed. The federal government released the 2020 Census data on August 12, 2021. However, the FAIR MAPS Act requires California to adjust the census data by reassigning state and county prisoners to their last known address. The official data from the State of California that cities are required to use for the redistricting process was released on September 16, 2021. After several modifications, the data was ready for the public to use in early October.



The delayed data release has compressed the redistricting process in hundreds of agencies across California. To address this challenge, the City of Palmdale launched a process to engage and inform the public early with redistricting information and prepare them to participate in the process once the official data was released and map drawing had commenced.

Building an Outreach Team

The City of Palmdale built a team of professionals to effectively execute the community outreach component of the project. This team included City of Palmdale staff, Tripepi Smith and National Demographics Corporation (NDC). These parties met jointly on regular calls to discuss the project and coordinate efforts. The integration of the demographer (NDC) into the outreach plan was designed to ensure that communications properly contributed to the broader goals of public information and drawing maps. This team approach helped eliminate silos of knowledge in this critical project, made more important by the challenging compressed timeline.





Tripepi Smith was engaged as an outreach expert on the redistricting process. The firm has a long history of collaboration with NDC and has worked with other cities to assist with their migration to district elections. During this redistricting cycle, the firm is working with over 20 other cities and counties on their redistricting outreach.

These outreach efforts were ably assisted by the City Clerk's team and the Communications team for the City of Palmdale.

Spanning Channels of Outreach

The City of Palmdale leveraged a full array of outreach platforms to connect with the public. These included:

- The City's website
- City social media channels
- Flyers distributed to the public
- Direct calls and emails to nearly 120 community leaders and organizations throughout Palmdale and the surrounding area (see list included in report)
- In-person Community Meetings throughout the City and virtual via Zoom



Redistricting Website

In the past six months (August 1, 2021 – February 9, 2022), there have been 4,464 Sessions on the City's Redistricting website. A Session is the period of time a user is actively engaged with the website. The website's Sessions in the past six months came from 3,139 Users who viewed 9,484 pages.

The Alianza Latina del Valle del Antilope, a Coalition of Latino organizations and community leaders including the Antelope Valley League of United Latin American Citizens-AV-LULAC, SALVA, Coalition for Humane Immigration Rights-Antelope Valley Chapter-CHIRLA-AV, The Dolores Huerta Foundation- Antelope Valley Chapter-DHF-AV, Café con Leche, Inc., Pueblo y Salud, Inc.-PyS, the American Civil Liberties Union-Antelope Valley Chapter-ACLU-AV, the Tavera Foundation, Latinx Council for the Prevention of Child Abuse-LCPCA, Helping Hands AV, Latino business and union representatives write to state their support for Palmdale Redistricting 2021 Public Maps 205 and 203.¹

They comply with Federal Law ensuring minimal population deviation limiting it to 2.90% in Map 205 and 3.81% in Map 203.

We also believe these plans comply with the Federal Voting Rights Act (VRA). Both of these maps create three Latino majority citizen voting age population (CVAP) districts, which may be required by the Federal Voting Rights Act (VRA). This is justified by the increase in Latino population during the past decade which currently comprises 62% of the City's total population. Please also note recent findings by Court of racially polarized voting (RPV) in Palmdale, which recently resulted in violations of voting rights of protected classes; in this case, Black voters and Latinos.²

Maps 205 and 203 take into consideration geographic contiguity while keeping communities of interest intact. They preserve the core of existing districts and anticipate future growth. When the City was last divided into districts, today's District 1 did not have Latinos as the majority of citizen voting age population. Today, that District has 53% Latino CVAP and it is anticipated that growth will continue in and around that district. Please note that Maps 205 and 203 have inverted district 1 and 2.

We thank you for the time and effort you have volunteered in order to ensure a fair and open redistricting process to date in the city of Paimdale.

We understand that the deadline for map submittal was January 3, 2022. However, it is our firm belief that the technical difficulties encountered by demographers providing technical assistance to us from two distinct Latino organizations, the Dolores Huerta Foundation (DHF) and the Mexican American Legal Defense and Education Fund (MALDEF), as well as other residents of Palmdale including members of ALVA, warrant this action on your part.
Demographers from both organizations struggled desperately to access and utilize the mapping tools provided to the public by DNC in your redistricting website. Technical problems with these tools were acknowledged by city staff, the submittal time frame was extended and efforts were made to correct these problems. However, these problems still diminished the time we had to adequately and sufficiently develop the prime maps that we wanted. As a result, and in order to comply with the submittal deadline, we supported two maps, # 203 and 206, that were not our primary choice and were not developed by us but sufficed in that they created three strong Latino districts.
In addition, the last two meetings of the Palmdale Redistricting Commission had an NDC representative as their key presenter. During both of these presentations, the latest just yesterday, maps were reviewed with no corresponding demographic information. This was extraordinarily shoddy in our view but more concerning was the acceptance of these presentations without question. Only two commissioners asked for demographics but never-the-less accepted the report at the end. Our inability to access the demographics of all maps as a result of NDCs shortcomings remains to this day a hindrance to an open and transparent process and impeded our ability to adequately discern other maps and compare them to our own, thus hindering our own map development process.
Given these facts and in keeping with NDC's encouraging words indicating that the more maps the better for the city ad its redistricting process, we urge you to accept this and all other maps that have been submitted after the January 3rd deadline and up to the date and time of this Council meeting, Januar 12, 2022 at 7:30 pm.
Please know that we submitted map #3 with corresponding demographics yesterday during the Palmdale Advisory Redistricting Meeting. Map #4 is being submitted today. These two maps reflect ALVAs primary choices.

COMMENTS OF THE ANTELOPE VALLEY LEAGUE OF UNITED LATIN AMERICAN CITIZENS TO THE PALMDALE ADVISORY REDISTRICTING COMMISSION DURING THE MEETING OF FEBRAURY 9, 2022

First, thank you for your voluntary work to ensure a fair and open redistricting process for Palmdale. We would like to go on record stating our support of your efforts and outcome to date.

We are disheartened, but not at all surprised, that the City Council would thwart your initial recommendation and firmly believe that any decision you formulate will not be accepted unless it fully protects the incumbency of those currently in office. This is their one primary concern as was made evident during the Council meeting of February 2, 2022.

We do not know if you are interested in sending maps to the Council that have as their primary objective the protection of incumbency but we would argue and recommend that you do not. You are under no obligation to derive of maps that protect incumbency. The City and you by extension, are under legal obligation to support maps that protect the voting rights of protected classes. In this circumstance, protected classes mean Latinos and African Americans.

A council member accused the creators of both map 208 and the ALVA map of politicizing the maps pitting Democrats against the Republican incumbents. He also accused the Commission of thwarting a "good faith effort to bring to the council four maps." Both of the accusations are preposterous, in our view.

We agree with the statements made by Councilman Carrillo during the Council meeting that the actions of the council were completely disrespectful of the Commission, the process they followed, and the community they represent with special emphasis on those community members who participated in the process.

Given what we see as an opportunistic and not so veiled attempt to corrupt the process, AV-LULAC urges you to resubmit the original maps. We urge you to allow the City Council to be responsible for their own actions. Do not allow yourselves and this Body to be used as a buffer. Place the onus back on them allow them to decide what maps they want instead of using you as a shield to guard them from the consequences of their actions.

ISSUE

Approve Ordinance No. 1580 continuing a temporary suspension of Section 5.04.670(H)(4) of the Palmdale Municipal Code prohibiting the sale of flavored cigarette products.

RECOMMENDATION

Staff recommends that the City Council:

- 1. Receive public testimony regarding Proposed Ordinance No. 1580; and
- Approve Ordinance No. 1580 continuing a temporary suspension of Section 5.04.670(H)(4) of the Palmdale Municipal Code prohibiting the sale of flavored electronic cigarette products.

BACKGROUND

The United States Food and Drug Administration ("FDA") has banned, through the authority granted to it by the Family Smoking Prevention and Tobacco Control Act, the sale of certain flavored tobacco products. However, despite the 2018 declaration of youth e-cigarette use epidemic by the FDA Commissioner and the United States Surgeon General, the federal ban on flavored tobacco products does not apply to electronic cigarette products.

On December 3, 2019, to protect young people from the harms of nicotine and abate their introduction to tobacco products, the City Council adopted Ordinance No. 1535, prohibiting the sale of flavored electronic cigarette products in the City of Palmdale. However, to accommodate the sale of a tobacco retailer's existing stock of flavored electronic cigarette products, to adjust inventories and accommodate the tobacco retailer's substitution of alternative products for sale, the City Council delayed implementation of this ordinance for six (6) months from its adoption.

Then, because of the government-mandated closures due to the COVID-19 pandemic, tobacco retailers did not receive the time initially contemplated by the City Council to sell their existing stock of flavored electronic cigarette products and to adjust inventories to comply with Ordinance No. 1535.

On July 14, 2020, the City Council, in an effort to provide tobacco retailers with the time frame initially contemplated by the City Council to sell current stock of flavored electronic cigarette products and to adjust inventories to comply with state and local tobacco retail laws, adopted Ordinance NO. 1548 suspending enforcement of the City's prohibition on the sale of Flavored Electronic Cigarette Products until February 1, 2021.

In August 2020, Senate Bill 793 passed which prohibited the sale of flavored tobacco in the State of California. However, shortly after the passage of SB 793, a group of tobacco manufacturers filed lawsuits seeking to prevent SB 793 from going into effect. In addition, a referendum, the California Flavored Tobacco Products Ban, qualified for the ballot as a veto referendum which suspended SB 793 until after the November 8, 2022 statewide general election.

On March 2, 2021, the City Council adopted Ordinance No. 1560 continuing a temporary suspension of PMC Section 5.04.670(H)(4) of the Palmdale Municipal Code, prohibiting the sale of flavored electronic cigarette products, until February 1, 2022.

DISCUSSION

Proposed Ordinance No. 1580 would continue the temporary suspension of Section 5.04.670(H)(4) of the Palmdale Municipal Code, prohibiting the sale of flavored electronic cigarette products, until February 1, 2023. The extended suspension would provide tobacco retailers additional time to adjust to the changing legal landscape regarding flavored tobacco products and allow the California Flavored Tobacco Products Ban Referendum to be voted on by California voters on November 8, 2022.

FISCAL IMPACT

Proposed Ordinance No. 1580 does not have any direct financial impact.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALMDALE CONTINUING A TEMPORARY SUSPENSION OF SECTION 5.04.670(H)(4) OF THE PALMDALE MUNICIPAL CODE PROHIBITING THE SALE OF FLAVORED ELECTRONIC CIGARETTE PRODUCTS

WHEREAS, Section 5.04.670 of the Palmdale Municipal Code regulates the sale of tobacco products, including electronic cigarette products.

WHEREAS, on December 3, 2019, to protect young people from the harms of nicotine and abate their introduction to tobacco products, the City Council adopted Ordinance No. 1535, prohibiting the sale of flavored electronic cigarette products in the city of Palmdale.

WHEREAS, in order to accommodate the sale of a tobacco retailer's current stock of flavored electronic cigarette products, to adjust inventories and accommodate the tobacco retailer's substitution of alternative products for sale, the City Council delayed implementation of Ordinance No. 1535 for six (6) months from its adoption.

WHEREAS, on March 4, 2020, the State of California and County of Los Angeles declared a State of Emergency in an effort to aid the prevention and mitigation of the effects of the COVID-19 outbreak throughout the State of California and the County of Los Angeles.

WHEREAS, on March 19, 2020, the Governor issued Executive Order N-33-20, directing the public to stay home and ordering the closure of all non-essential businesses, including tobacco retailers.

WHEREAS, Senate Bill 793 was adopted and enrolled in August 2020, prohibiting the sale of flavored tobacco in the state of California.

WHEREAS, shortly after the passage of SB 793, a group of tobacco manufacturers filed lawsuits seeking to prevent SB 793 from going into effect.

WHEREAS, a referendum on SB 793 qualified for the ballot and SB 793 is suspended until the referendum vote in November 2022.

WHEREAS, on July 14, 2020, the City Council, in an effort to provide tobacco retailers with the time initially contemplated by the City Council to sell current stock of flavored electronic cigarette products and to adjust inventories to comply with state and

local tobacco retail laws, adopted Ordinance No. 1548 suspending enforcement of the City's prohibition on the sale of Flavored Electronic Cigarette Products until February 1, 2021.

WHEREAS, on March 2, 2021, the City Council, in an effort to provide tobacco retailers additional time to adjust to the changing legal landscape regarding flavored tobacco products, adopted Ordinance No. 1560 suspending enforcement of the City's prohibition of the sale of Flavored Electronic Cigarette Products until February 1, 2022.

WHEREAS, the City Council desires to provide tobacco retailers additional time to adjust to the impacts of COVID-19 and the changing legal landscape regarding flavored tobacco products as the California Flavored Tobacco Products Ban Referendum qualified for the ballot as a veto referendum and is scheduled for a vote which is to occur on November 8, 2022.

THE CITY COUNCIL OF THE CITY OF PALMDALE DOES ORDAIN AS FOLLOWS:

SECTION 1. Temporary Suspension of Section 5.04.670(H)(4). The prohibition on the sale of Flavored Electronic Cigarette Products, as detailed in Section 5.04.670(H)(4) of the Palmdale Municipal Code, is temporarily suspended until February 1, 2023.

<u>SECTION 2</u>. <u>Severability</u>. If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one (1) or more subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, or invalid, or ineffective, provided the basic purposes of this Ordinance and the benefits to the City and the public are not substantially impaired.

SECTION 3. The City Council finds the approval of this ordinance is not subject to the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Sections 15060(c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment) and 15060(c)(3) (the activity is not a project as defined in Section 15378) of the CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, because it has no potential for resulting in physical change to the environment, directly or indirectly. Alternatively, the City Council finds the approval of this ordinance is not a project under CEQA Regulation Section 15061 (b)(3) because it has no potential for causing a significant effect on the environment.

SECTION 4. The City Clerk shall certify to the adoption of this ordinance and shall cause this ordinance to be published or posted as required by law.

ISSUE

Adopt Ordinance No. 1571 amending Palmdale Municipal Code Section 8.34 et. seq.: Regulation of Smoking at Public Places of Employment.

RECOMMENDATION

Staff recommends that the City Council:

- 1) Receive Public Testimony;
- 2) Approve the introduction of proposed Ordinance No. 1571; and,
- 3) Adopt Ordinance No. 1571 amending Palmdale Municipal Code Section 8.34 et. seq.: Regulation of Smoking at Public Places and Places of Employment.

BACKGROUND

In 1993, by City of Palmdale Ordinance No. 1024, the City of Palmdale established smoking regulations in the City. The Palmdale Municipal Code general smoking regulations were last updated in 2014. At the City Council meeting on January 12, 2022, Council was presented with proposed amendments to the smoking Ordinance and directed staff to return in February 2022 with updates to the City of Palmdale smoking Ordinance.

DISCUSSION

Proposals have been submitted to City Staff and Councilmembers by local advocacy groups seeking amendments to the Palmdale Municipal Code and the regulation of smoking in the City. Council has directed these items be incorporated into an Ordinance. Attached to this Staff Report is an Ordinance that amends the Palmdale Municipal Code as follows:

8.34.030 Definitions. [Highlighted in red with additions and amendments]

For the purpose of this chapter certain words and phrases shall be defined as follows:

"Bar" means an establishment which is devoted to the serving of alcoholic beverages for consumption by patrons on the premises and in which the serving of food is only incidental to the consumption of such beverages. Although a restaurant may contain a bar, the term "bar" shall not include any restaurant dining area.

"City" means the City of Palmdale.

"Employee" means any person engaged in the operation or conduct of any business in the City, whether as an owner, a member of the family, or as a partner, agent, manager, solicitor, apprentice, trainee or any other category of person employed or working in such business.

"Employer" means any person, partnership, corporation, including a municipal corporation or nonprofit entity, who engages the services of one or more individuals.

"Enclosed area" means all space between a floor and ceiling which is enclosed on all sides by solid walls or windows (exclusive of door or passage ways) which extend from the floor to the ceiling, including all space therein screened by partitions which do not extend to the ceiling or are not solid.

"Golf Courses" means driving ranges, dining areas and service areas at golf courses; and within 35 (thirty-five) feet of any building doorway or window of any dining or service areas.

"Nonprofit entity" means any corporation, unincorporated association or other entity created for charitable, philanthropic, educational or other similar purposes, the net proceeds from the operation of which are committed to the promotion of the objectives or purposes of the organization and not for private financial gain.

"Non-enclosed" means a predominantly outdoor area that does not meet the definition of "enclosed," including but not limited to patios, outdoor dining areas, and outdoor service areas.

"Outdoor public service area" means any non-enclosed area where one or more persons wait for or receive goods or services of any kind, including but not limited to: lines or waiting areas for ATM machines, information kiosks, outdoor restaurants and other food services, outdoor waiting areas for tickets and admission to a theater or event; waiting areas at car washes and vehicle service establishments; and streets and

sidewalks that are designed to be used or are regularly used by one or more persons to receive a service or wait to receive a service.

"Outdoor Dining Area" means any publicly or privately owned outdoor area, including streets and sidewalks, that is available to or customarily used by the general public or an employee, and that is designed, established, or regularly used for consuming food or drink.

"Outdoor Worksites" means any outdoor area under the legal or de facto control of an employer that an employee or the general public may enter in the normal course of operations, but regardless of the hours of operation.

"Place of employment" means any area under the legal or de facto control of an employer that an employee or the general public may enter in the normal course of operations, but regardless of the hours of operation, including but not limited to: indoor and outdoor work areas, construction sites, vehicles used in employment or for business purposes, rideshare services, employee lounges, conference and banquet rooms, bingo and gaming facilities, long-term health facilities, warehouses, and any private residences subject to state licensing requirements that are used as child-care or health-care facilities.

"Public place" means any area to which the public is generally invited or permitted.

"Restaurant" means any coffee shop, cafeteria, sandwich stand, private and public school cafeteria, including any associated outdoor eating area, and any other eating establishment which gives or offers for sale food to the public, guests or employees, as well as kitchens in which food is prepared on the premises for serving elsewhere, including catering facilities, except that the term "restaurant" shall not include a cocktail lounge or bar as defined in this section.

"Sidewalks" means any public or private sidewalk within the city.

"Smoking" means the inhaling, exhaling, burning or carrying of any lighted, heated, or ignited cigar, cigarette, cigarillo, pipe, cannabis, hookah, electronic smoking device, or any other combustible substance in any manner or in any form. Smoking includes the use of an electronic cigarette or any other electronic and/or battery-operated device used to deliver an inhaled dose of nicotine or other substance.

"Tobacco store" means a retail establishment, the primary use of which is the sale of tobacco products and accessories and in which the sale of other items is merely incidental.

"Waiting lines or areas" means any indoor line or area in which one or more persons are waiting for or receiving service of any kind, whether or not such service involves the exchange of money or other consideration. (Ord. 1456 § 2, 2014; Ord. 1024 § 1, 1993)

8.34.040 City-owned, leased or operated facilities

- (A) All enclosed facilities which are owned, leased or operated by the City, including vehicles, shall be subject to the provisions of this chapter.
- (B) Smoking shall be prohibited at all outdoor facilities, including parks, which are owned, leased or operated by the City.
- (C) Notwithstanding the provisions of subsection (B) of this section, smoking shall be prohibited, except in those areas designated as smoking areas, at the following facilities:

ORDINANCE NO. 1571

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALMDALE AMENDING MUNICIPAL CODE SECTION 8.34 ET. SEQ.; REGULATION OF SMOKING AT PUBLIC PLACES AND PLACES OF EMPLOYMENT

WHEREAS, the City of Palmdale has a commitment to public health and safety within the City; and

WHEREAS, Strategic Plan Goal III(C) sets forth a directive to, "Plan and maintain safe and attractive neighborhoods, streets, facilities and public spaces...", and

WHEREAS, the use of tobacco, nicotine, and smoking products has been proven to have deleterious effects on the health of users; and

WHEREAS, the use of tobacco, nicotine, and smoking products has been proven to have deleterious effects on those exposed to such products, even if not the user; and

WHEREAS, proper regulation and control is necessary to ensure public health.

NOW, THEREFORE, BE IT RESOLVED, THE CITY COUNCIL OF THE CITY OF PALMDALE DOES HEREBY FIND, DETERMINE, RESOLVE AND ORDER AS FOLLOWS:

SECTION 1. The City of Palmdale Municipal Code is hereby amended at Chapter 8.34 et. seq. as follows:

8.34.030 Definitions.

For the purpose of this chapter certain words and phrases shall be defined as follows:

"Bar" means an establishment which is devoted to the serving of alcoholic beverages for consumption by patrons on the premises and in which the serving of food is only incidental to the consumption of such beverages. Although a restaurant may contain a bar, the term "bar" shall not include any restaurant dining area.

"City" means the City of Palmdale.

"Employee" means any person engaged in the operation or conduct of any business in the City, whether as an owner, a member of the family, or as a partner, agent, manager, solicitor, apprentice, trainee or any other category of person employed or working in such business.

"Employer" means any person, partnership, corporation, including a municipal corporation or nonprofit entity, who engages the services of one or more individuals.

"Enclosed area" means all space between a floor and ceiling which is enclosed on all sides by solid walls or windows (exclusive of door or passageways) which extend from the floor to the ceiling, including all space therein screened by partitions which do not extend to the ceiling or are not solid.

"Golf Courses" means driving ranges, dining areas and service areas at golf courses; and within 35 (thirty-five) feet of any building doorway or window of any dining or service areas.

"Nonprofit entity" means any corporation, unincorporated association or other entity created for charitable, philanthropic, educational or other similar purposes, the net proceeds from the operation of which are committed to the promotion of the objectives or purposes of the organization and not for private financial gain.

"Non-enclosed" means a predominantly outdoor area that does not meet the definition of "enclosed," including but not limited to patios, outdoor dining areas, and outdoor service areas.

"Outdoor public service area" means any non-enclosed area where one or more persons wait for or receive goods or services of any kind, including but not limited to: lines or waiting areas for ATM machines, information kiosks, outdoor restaurants and other food services, outdoor waiting areas for tickets and admission to a theater or event; waiting areas at car washes and vehicle service establishments; and streets and sidewalks that are designed to be used or are regularly used by one or more persons to receive a service or wait to receive a service.

"Outdoor Dining Area" means any publicly or privately owned outdoor area, including streets and sidewalks, that is available to or customarily used by the general public or an employee, and that is designed, established, or regularly used for consuming food or drink.

"Outdoor Worksites" means any outdoor area under the legal or de facto control of an employer that an employee or the general public may enter in the normal course of operations, but regardless of the hours of operation.

"Place of employment" means any area under the legal or de facto control of an employer that an employee or the general public may enter in the normal course of operations, but regardless of the hours of operation, including but not limited to: indoor and outdoor work areas, construction sites, vehicles used in employment or for business purposes, rideshare services, employee lounges, conference and banquet rooms, bingo and gaming facilities, long-term health facilities, warehouses, and any private residences subject to state licensing requirements that are used as child-care or health-care facilities.

"Public place" means any area to which the public is generally invited or permitted.

"Restaurant" means any coffee shop, cafeteria, sandwich stand, private and public school cafeteria, including any associated outdoor eating area, and any other eating establishment which gives or offers for sale food to the public, guests or employees, as well as kitchens in which food is prepared on the premises for serving elsewhere, including catering facilities, except that the term "restaurant" shall not include a cocktail lounge or bar as defined in this section.

"Sidewalks" means any public or private sidewalk within the city.

"Smoking" means the inhaling, exhaling, burning or carrying of any lighted, heated, or ignited cigar, cigarette, cigarillo, pipe, cannabis, hookah, electronic smoking device, or any other combustible substance in any manner or in any form. Smoking includes the use of an electronic cigarette or any other electronic and/or battery-operated device used to deliver an inhaled dose of nicotine or other substance.

"Tobacco store" means a retail establishment, the primary use of which is the sale of tobacco products and accessories and in which the sale of other items is merely incidental.

"Waiting lines or areas" means any indoor line or area in which one or more persons are waiting for or receiving service of any kind, whether or not such service involves the exchange of money or other consideration. (Ord. 1456 § 2, 2014; Ord. 1024 § 1, 1993)

8.34.040 City-owned, leased or operated facilities

- (A) All enclosed facilities which are owned, leased or operated by the City, including vehicles, shall be subject to the provisions of this chapter.
- (B) Smoking shall be prohibited at all outdoor facilities, including parks, which are owned, leased or operated by the City.

- (C) Notwithstanding the provisions of subsection (B) of this section, smoking shall be prohibited, except in those areas designated as smoking areas, at the following facilities:
 - (1) Palmdale Amphitheater;
 - (2) Palmdale Transportation Center; and
 - (3) Larry Chimbole Cultural Center.
 - (4) DryTown Water Park
 - (5) Palmdale Playhouse
 - (6) Palmdale City Libraries
- (D) The City Manager, or his or her designee, is authorized to establish, and change, the designated smoking area(s) for each facility identified in subsection (C) of this section. The City Manager, or his or her designee, shall conspicuously post, or cause to be posted, at every designated smoking area, signs identifying that area as a location where smoking is permitted. If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase

thereof irrespective of the fact that any one (1) or more subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional, or invalid, or ineffective, provided the basic purposes of this Ordinance and the benefits to the City and the public are not substantially impaired.

SECTION 3. Certification. The City Clerk shall certify to the adoption of this Ordinance and shall cause this Ordinance to be published or posted as required by law.

SECTION 4. Effective Date. This Ordinance shall take effect 30 days after its adoption.

BACKGROUND

On October 5, 2021, the Palmdale City Council authorized the creation of the Palmdale Tourism Improvement District (PTID) with the adoption of Resolution No. CC 2021-096. A PTID is a partnership between the City and hotels in Palmdale to create additional tourism and visitor opportunities that both visitors and residents can enjoy. The benefits an improvement district provides can come in a variety of forms such as signature events, enhancing current tourism attractions, development of additional destinations and infrastructure improvements. An increase in tourism and business travel positively impacts hotels, restaurants, and local small businesses.

Visit Palmdale is the governing board of the PTID. The board will have the responsibility of managing the services and programs provided by the PTID in Palmdale.

The Board of Directors for Visit Palmdale is made up of seven (7) directors; four (4) from Palmdale businesses who represent the PTID, one (1) City Councilmember, one (1) City staff person, and one (1) person who represents tourism and the non-lodging hospitality sector in Palmdale. This mirrors the formation of Destination Lancaster's Board of Directors when the board was first established. Each member is appointed for a three (3) year term.

DISCUSSION

The City Council is responsible for the appointment of the three individuals to the Visit Palmdale Board of Directors. Per the Visit Palmdale Bylaws, the Directors shall be appointed by the Mayor, subject to the approval of a majority of the City Council.

On December 23, 2021, the City posted the vacancy for an at-large board member for the Visit Palmdale Board of Directors on the City Website and through a public notice in the AV Press. BACKGROUND

At the General Municipal Election held on November 3, 2020, voters approved the enactment of a local ¾ cent transaction and use tax in the City of Palmdale. On December 15, 2021, Eric Ohlsen was appointed as the Regular Member to District 4, replacing Maribel Briseno, who had accepted full-time employment with the City. The Office of the City Clerk received subsequent notice from District 4 Alternate Member Roger Villasenor, indicating his resignation form the alternate position due to personal reasons.

On January 19, 2022, the City Council directed the City Clerk to extend the recruitment period to afford additional members of the community the opportunity to apply to fill the vacancy. A Notice of Vacancy was advertised in the Antelope Valley Press on January 20, 2022. The Classified Ad and the application were made available on the City's website as well as in the Office of the City Clerk. Staff received four (4) applications by the February 8, 2021, in addition to the five (5) applicants presented to Council on January 19th for a total of nine (9) candidates to choose from.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PALMDALE AMENDING
THE PALMDALE MUNICIPAL CODE SECTION 2.08.030 REGARDING
APPOINTMENTS TO BOARDS AND COMMISSIONS BY THE CITY COUNCIL

WHEREAS, On July 2, 2008, the City Council passed and adopted Ordinance No. 1357 that amended Section 2.08 of the Palmdale Municipal Code (PMC).

WHEREAS, PMC Section 2.08.030 governs the manner in which appointments are made to boards and commissions of the City Council.

WHEREAS, The method and manner of appointments pursuant to the amended PMC 2.08.030 is such that the mayor is responsible for all appointments to said boards and commissions, with ratification by the City Council.

WHEREAS, Under the PMC 2.08.030, the mayor is to nominate all persons to boards and commissions, and there is no 'second' required for such nomination.

WHEREAS, Under the PMC 2.08.030, city council members do not have the ability to nominate persons to boards and commissions.

THE CITY COUNCIL OF THE CITY OF PALMDALE DOES ORDAIN AS FOLLOWS:

<u>SECTION 1</u>. <u>Amend Palmdale Municipal Code Section 2.08.030</u> Repeal and replace Palmdale Municipal Code Section 2.08.030 to read as follows:

PMC 2.08.030: Appointments to Boards, Commissions, and Committees

Unless otherwise specifically provided in this code or by State Law, the City Council shall make all appointments to boards, commissions and committees of the City as follows unless otherwise formed by Resolution:

- A. City Council boards, commissions and committees shall consist of a minimum of five members, of whom shall be nominated by each City Councilmember and the Mayor, subject to approval by the City Council for appointment. All members shall be voting members of the board, commission, or committee. No member shall be a member of the City Council. It is preferable that City Councilmember's appointee reside within the Councilmember's district, however, is not required when subject matter expertise is desirable. The Mayor may nominate an individual that represents the City at large whom may reside in any district. Members serve at the pleasure of the City Council and may be removed prior to the expiration of their term by a vote of a majority of the members of the City Council.
- B. All board and commission vacancies shall be advertised, seeking volunteers willing and desiring to be appointed to fill such vacancies. Any person seeking to be so appointed must complete and submit the city volunteer application, together with any other information requested by the City Council as appropriate for a specific board or commission.
- C. All such applications shall be provided to the Mayor and City Council for review, who shall, at a regularly scheduled City Council meeting, nominate, from among such applicants, the persons whom the Mayor and a City Councilmember desires to appoint by making a motion which need not be seconded, for each such appointment.
- D. If the nomination by the Mayor and City Councilmember is approved by a majority vote of the City Council, the nominating City Councilmember may then proceed to appoint the person to the board or commission under consideration.
- E. If the specific nomination by the Mayor and/or City Councilmember is not approved by a majority vote of the City Council, the City Council will nominate, by motion, a different candidate until someone is approved by majority vote of the City Council for the position under consideration.
- F. All members of boards, commissions and committees serve at the pleasure of the City Council and are subject to removal by a majority vote of the City Council.

SECTION 2. Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase in this Ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one (1) or more subsections, subdivisions, paragraphs,

sentences, clauses or phrases be declared unconstitutional, or invalid, or ineffective, provided the basic purposes of this Ordinance and the benefits to the City and the public are not substantially impaired.

SECTION 3. The City Council finds the approval of this ordinance is not subject to the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Sections 15060(c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment) and 15060(c)(3) (the activity is not a project as defined in Section 15378) of the CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, because it has no potential for resulting in physical change to the environment, directly or indirectly. Alternatively, the City Council finds the approval of this ordinance is not a project under CEQA Regulation Section 15061 (b)(3) because it has no potential for causing a significant effect on the environment.

SECTION 4. The City Clerk shall certify to the adoption of this ordinance and shall cause this ordinance to be published or posted as required by law.

CITY OF PALMDALE MEASURE AV OVERSIGHT COMMITTEE BYLAWS

ARTICLE I - ESTABLISHMENT AND PURPOSE

- **A. Name.** Official name of the committee shall be Measure AV Oversight Committee (the "Committee")
- B. Compensation. No compensation shall be provided for attendance to Committee meetings. Reimbursement shall only be given for expenses actually incurred in connection to serving on the Committee.
- **C. Establishment.** Measure AV, approved in November 2020, calls for the establishment of a committee to ensure that all funds from the measure are appropriately used.
- D. **Purpose.** The purpose of this Committee is set forth in Measure AV. (Protecting Palmdale's long-term financial stability; maintaining essential city services; repairing streets/potholes; addressing homelessness; maintaining 911 emergency response; keeping public areas safe/clean for all; retaining local businesses; protecting local water sources; maintaining veterans, senior, mental health, community programs; by establishing a ¾-cent sales tax; requiring citizen oversight, public spending disclosures; all funds used locally in Palmdale). These Bylaws are specifically made subject to the applicable provisions of Measure AV as to the duties and rights of the Committee. The Committee is subject to the Ralph M. Brown Public Meetings Act of the State of California and shall conduct its meetings in accordance with the provisions thereof.

- **E. Administrative Support.** The City shall give all necessary administrative support to the Committee, as is consistent with the Committee's purpose.
- **F. Duties.** The duties of this Committee are:
 - a. To ensure that all funds from the three-quarters cent sales tax are spent in accordance with Measure AV.
 - b. To prepare an annual written report setting forth the purposes for which Measure AV funds were expended in the preceding year and the amount spent in each category.

ARTICLE II - POSITIONS AND TERMS

- **A. Committee Members.** Committee Members shall consist of seven (7) members and (7) alternatives.
- **B.** Committee Additions and Subtractions. The City Council may, by unanimous decision, vote to add or subtract the number of members on the Committee, but shall not go lower than five (5) total members. The Committee shall always remain at an odd number.
- C. Term Length. Each member of the Committee shall be appointed for a two (2) year term.
- **D. Term Limit.** Committee members are limited to a three (3) term limit for serving on the Committee.
- **E. Committee Vacancy.** Should a vacancy arise from a member resigning or other matters the following shall happen:
 - **a.** Replacement will be filled by a Committee alternate member.

- b. A Replacement for that alternate shall be picked by the City Council and voted in by majority vote.
- c. If a vacancy is filled and there is greater than a year left on the term, it shall count as a full term for the appointed Committee Member's term limit.
 If less than a year remains on the term, it shall not count towards the Committee Member's term limit.
- F. Forfeiture. Should any Committee member miss three (3) consecutive

 Committee meetings without any prior consent or notice to the Committee, they
 shall forfeit their membership on the Committee. All forfeited Committee positions
 shall be subject to Article II, Section E, for the purpose of their vacancy.
- G. Chair. The Committee shall appoint one member to serve as the Chair of the Committee by a simple majority vote. The Chair shall preside at all meetings of the Committee. The Chair is responsible for keeping order and decorum during the Committee's meetings.
- H. Vice-Chair. The Committee shall appoint one member to serve as the Vice-Chair of the Committee by simple majority vote. The Vice-Chair shall perform the duties of the chair in the absence or incapacity of the Chair, until such time as a new Chair is selected or appointed. Should both the Chair and Vice-Chair be absence or incapacitated, the Committee shall vote by simple majority to appoint an interim Chair and Vice-Chair for the purpose of that current meeting and any subsequent meetings until either the Chair or Vice-Chair are able to return to their duties.

I. Staff Secretary. City staff shall appoint one member to serve as the Staff Secretary of the Committee. The Staff Secretary shall keep the minutes of all official meetings of the Committee, which shall be open for inspection by any member of the public. The Staff Secretary shall sign reports and correspondence for the Committee, along with setting meeting dates; providing agendas to each Committee member prior to each official meeting. The Staff Secretary shall inform Committee members of all available data gathered by City staff pertinent to each item on said agenda. The Staff Secretary shall inform Committee members of the time and place of any special meeting. The Staff Secretary shall make available to the Committee all correspondence addressed to the Committee.

ARTICLE III – MEETINGS

- **A.** Rules. All meetings will fall under rules set by the Ralph M. Brown Act (Cal. Gov't Code §54950 et seq.) ("Brown Act").
- **B. Meeting Dates.** Use of set dates and locations shall be established to meet no less than four (4) times a year. These set dates can be changed by resolution as needed.
- C. Specials Meetings and Emergency. Special Meetings can be called by the Chair or Vice Chair with five days prior notice. Emergency meetings can be called as needed.
- **D.** Open and Public Meetings. All meetings concerning all Committee actions and deliberations shall be open and allow for anyone in the public to attend.

- **E. Closed Sessions.** Closed sessions are allowed during regular or special meeting as is needed by circumstance and permitted by law.
- **F. Public Hearings.** Public hearings are to be conducted during regular or special meetings of the Committee.
- G. Agenda. An agenda shall be published to the public and sent out to each Committee member no less than seventy-two (72) hours before the meeting takes place. All agendas should include time, date, and location that the meetings take place along with the type of meeting (Regular, Special, or Emergency). Any items not on the agenda will be placed in the non-agenda items portion of the meeting.
- H. Minutes. Minutes of the proceedings of the Committee and all documents received and reports issued shall be a matter of public record and be made available on an Internet website maintained by the Committee.

ARTICLE IV. - CONDUCT OF MEETINGS

- **A. Order of Business.** The regular order of business shall be:
 - 1. Call to Order
 - 2. Approval of Prior Meetings Minutes
 - Consideration and Action of Agenda Items
 - 4. Non-Agenda Items
 - 5. Public Comment
 - 6. Adjournment

The order of business can be modified as needed.

- **B.** Parliamentary Procedure. All proceedings before the Committee may be guided by the rules of parliamentary procedure set forth in Robert's Rules of Order, but failure to follow Robert's Rules of Order shall not affect the validity of any action or motion duly taken or adopted by the Committee at any lawfully held meeting.
- C. Presentations to the Committee. Any person desiring to address the Committee shall be requested, when recognized by the Chair, to give his or her name and address for the record. The Chair may, in the interest of facilitating the business of Committee, set in advance of the presentation of testimony reasonable time limits for oral presentations. Persons may be required to submit written testimony in lieu of oral testimony if the Chair determines that a reasonable opportunity for oral presentations has been provided, and in such a case, the matter may be continued to a later date to allow a reasonable time for such submittals to occur.
- D. Attendance. Members shall be considered present at the Committee meeting if they are there physically, on the phone, or using a video conferencing application.

ARTICLE V. - VOTING AND QUORUM

- **A. Roll Call Vote.** A roll call vote may be required in voting upon any motion of the Committee in the discretion of the Chair.
- **B. Quorum.** A majority of the currently appointed members of the Committee shall constitute a quorum for the purpose of conducting its business and exercising its powers and for all other official purposes, except that less than a quorum may adjourn from time to time until a quorum is obtained.

- **C. Number of Votes Required for Action.** All actions require a motion and a second. No action or recommendation of the Committee shall be valid and binding unless a quorum is present and the motion is approved a simple majority of the members present. Each member shall have one vote. No votes may be cast by proxy. Tie votes shall be considered as denial of the motion.
- **D. Conflicts of Interest.** The Committee shall be subject to conflict of interest in accordance with the Fair Political Practices Act. City Councilpersons shall not vote for any person who presents a conflict of interest with them.

E. Motion to Reconsider. The Committee may reconsider a matter during the meeting at which the vote was taken, provided all members who were present when the matter was discussed and voted upon are still present, all persons who addressed the Committee regarding the matter are still present, and the motion to reconsider is made by a member who voted with the prevailing side. A motion for reconsideration shall have precedence over every motion except a motion to adjourn. A final vote on any matter may also be placed on any future agenda for reconsideration by the Committee or any member of the Committee at the meeting at which the actions was taken or at any later time. Any interested person may request that an action be reconsidered, provided that such a request must be in writing and filed with the Palmdale City Clerk within ten calendar days of the action of the Committee.

ARTICLE VI. - AMENDMENTS.

Any amendment to these Bylaws shall be approved by a simple majority vote of the Committee of the entire Committee.
